**Presiding Officer and Quorum**

Linda Brunson, President, called the meeting to order and Wanda Reese acted as Secretary at the meeting. With all of the members of the Board in attendance, a quorum of the directors was present, and the meeting having been duly convened, began.

**Approval of Minutes**

The minutes of the previous meeting of the Board of Directors on May 19, 2020 were adopted.

**Financial Statement**

The projected financial statement for the year ended May 31, 2020 was approved.

**Election of Directors**

All four directors have now served their initial fiscal year of their three-year term:

It was discussed that the PTA could appoint someone to our Board and that a teacher could be added to the Board. No further action was taken.

## Goals


The *primary* goals for the 2021-2022 school year are as follows:

- **Know & Grow**
  - The Know & Grow Wordbooks for kindergarten and first grade are extremely popular. The Know & Grow flashcards should also be continued.
- **Science Enrichment**
  - Funding has been obtained for the Mystery Science subscription and supplies for the 2021-2022 school year
  - Funding will be sought for more fifth grade science teaching tools.
- **School Beautification**
  - The CSX grant has provided a great opportunity to improve the school grounds. The school beautification of the grounds in front of the school is complete. The new outside bulletin board will be installed at the front entrance following a pressure washing of the area. The grounds near the bus loop still require work.
- **Reading Buddies**
  - The tutoring program came to an abrupt halt with COVID-19. Hopefully the "new normal" will allow us to restart this program. Recruiting will be done differently. All local businesses and organizations will be requested to provide one Reading Buddy.
- **Grant Writing**
  - Seek funding for projects requested by teachers and the school principal.
